## Contract

In order for us to provide you with an optimal service, please note the following:

### **Harpist Information:**

- One free private consultation will be available to the client and conducted at VeeRonna's home.
- The harp may not be placed directly on an unstable surface such as grass or dirt. A solid 4'by5' covering such as dance floor, wood, or tile must be provided by the client to protect the harp. It must be able to support approximately 300lbs.
- When temperatures exceed 80 degrees, the instrument(s) must be completely shaded.
- When temperatures drop below 65 degrees, a space heater must be provided for the musicians. The instruments can not be exposed to rain or a mist system.
- If a vocalist requires a song in another key to best suit his/her range, the sheet music must be provided a minimum of one month prior to the event. If sheet music is unavailable in the new key, VeeRonna may be able to transpose most chord charts with a one month notice as well. A small fee will be charged. If the vocalist requires a private rehearsal, the rehearsal itself will be conducted with VeeRonna at her home. Rehearsal time will be at a rate of \$25.00 per hour. There is a minimum one hour charge.
- If under any circumstances the musicians are unable to fulfill their contractual obligation, the fees paid shall be refunded or the musicians will do all that is reasonably possible to find a qualified substitute.

### **Minister Information:**

- One free private consultation to be available to client and conducted at an agreeable location.
- Marriage resources shall be available to client if desired.
- Marriage license to be obtained by client at (602) 506-3676
- If under any circumstances the minister is unable to fulfill his contractual obligation, the fees paid shall be refunded or the minister will do all that is reasonably possible to find a qualified substitute.
